DO'S AND DON'TS TO BE FOLLOWED BY HON'BLE JUDGES/JUDICIAL OFFICERS IN CASE OF CONTINGENCY:

DO's

- Kindly immediately proceed to the chamber in case of contingency, and lock the door from inside.
- 2. It is suggested that more than one Hon'ble Judges proceed to the single chamber so that PSOs/Court staff can provide proper security cover.
- 3. Please switch off the lights and remain away from the doors and windows.
- 4. Kindly remain with PSOs/Court staff for safe evacuation to Safe Houses, respective residence or designated hospitals as per SOP or as per the situation.
- 5. Kindly share health profile (blood group/allergies, etc.) with PSOs that can be useful in the event of any medical contingency.
- 6. For safe evacuation, designated gates may be used, as per the situation.
- 7. Please listen to the directions of announcements being made on the PA System.

DON'Ts

- 1. Please do not panic and remain composed.
- Please do not be in a hurry to exit from Safe Houses/court complex since adequate security cover and facilities will be made available at Safe Houses.

DO'S AND DON'TS TO BE FOLLOWED BY DELHI HIGH COURT REGISTRARS, OFFICIALS AND COURT STAFF IN CASE OF CONTINGENCY:

GENERAL GUIDELINES FOR ALL CONTINGENCIES:

(i) Be aware of your surroundings.

- (i) In the event of Armed intrusion or bomb blast from Justice Sunanda Bhandare Marg side, Court officials and court staff present in the court shall be safely evacuated from peripheral gate Nos. 4, 5, 6, 7, 8 & 9.
- (ii) In the event of Armed intrusion or bomb blast from Sher Shah Road side, Court officials and court staff shall be safely evacuated from peripheral gate Nos. 5, 6, 7, 8 & 9.
- (iii) In the event of Armed intrusion or bomb blast from Bappa Nagar Road side, Court officials and court staff shall be safely evacuated from peripheral gate Nos. 4, 5, 6 & 7.

- (iv) In the event of Armed intrusion or bomb blast from Service Road, NDMC school block side, Court officials and court staff shall be safely evacuated from peripheral gate Nos. 4, 8 & 9.

DO's

- Registrar General with team members to kindly maintain close coordination with the DCP/ACP/Delhi High Court Security and Incident Commander to evacuate the Hon'ble Chief Justice and other fellow Judges to the Safe Houses or designated hospitals, as per the situation.
- Registrar General and other officials shall also assist in identifying and safeguarding important assets before evacuation in the event of any contingency.
- 3. Registrar General will provide the necessary gadgets for effective handling of the process of evacuation.
- Registrar General will also keep the Map of the complexes handy, and share with DCP/ACP/Delhi High Court Security for appropriate announcement for smooth evacuation of persons from the affected area(s).
- 5. To arrange First Aid & Disaster kits to be utilized during contingency.

ARMED INTRUSION:

(i) To move quickly into the nearest room/office/court rooms and lock the doors from inside and wait for further directions/announcement made through integrated PA System.





- (ii) Swiftly move to the Court Rooms, Lawyer's Chambers, Court Buildings, Basement Parking, nearby rooms or as per directions/announcement made through integrated PA System.
- (iii) While inside the room, keep yourself away from windows, glass doors, or other potentially hazardous areas.
- (iv) If exposed in open area during indiscriminate firing, lie flat behind brick walls, any cover, large trees, parked vehicles, or any other object that may stop bullet.
- (v) Do not run in a straight line. Try to keep objects (wall, trees, vehicles, etc.) between you and the intruder(s).
- (vi) Give a description of the intruder's sex, race, clothing, type of weapon(s), location last seen, direction of travel and identity to the authorities.

HOSTAGE SITUATION:

- (i) Be patient. Avoid drastic action.
- (ii) The first few minutes are the most dangerous. Be alert and follow instructions.
- (iii) Don't speak unless asked for.
