Item No. 7:

Keeping in view the paucity of space available with the Registry, it is recommended that the Registry shall compile a list of cases where the arbitral records have not been collected by the counsels, despite the fact that the cases stand disposed of. These records shall then be scanned and subsequently destructed/weeded out, with notice regarding the said action posted on this Court's website for a period of one month.
