General Note :

- 1. All fresh PILs shall be listed before the Bench presided over by the Chief Justice.
- 2. Mentioning of urgent matters will be before DB-I.

- 3. Matters other than part-heard, presently pending before various Benches, shall stand transferred to the respective Benches as per the above roster.
- 4. All PIL Matters including suo moto petitions irrespective of they being part heard (other than those transferred by the Roster Bench) be listed before the Roster Bench i.e. DB-1.
- 5. Regular/final hearing matters would be listed chronologically so that old matters can be given priority in disposal.
- 6. Specially directed matters may be assigned by the Chief Justice to any of the above Benches or any of the Hon'ble Judges sitting singly or to specially constituted Benches.
- 7. 'Commercial Appellate Division' has been constituted with four Division Benches, namely, DB-I, DB-III, DB-IV & DB-VI. Hon'ble Judges who are members of said Division Benches, as per the present roster, have been nominated as Judges of the 'Commercial Appellate Division'.
- 8. Matters to be heard by the Commercial Appellate Divisions shall be assigned by the Chief Justice amongst four Commercial Appellate Divisions.
- 9. 'Commercial Division' consist of seven benches of a Single Judge each. Hon'ble Mr. Justice Subramonium Prasad, Hon'ble Mr. Justice Jasmeet Singh, Hon'ble Mr. Justice Amit Bansal, Hon'ble Ms. Justice Mini Pushkarna, Hon'ble Mr. Justice Vikas Mahajan, Hon'ble Ms. Justice Manmeet Pritam Singh Arora and Hon'ble Mr. Justice Sachin Datta have been nominated to be the Judges of the 'Commercial Division'.
- 10. Hon'ble Mr. Justice Amit Bansal and Hon'ble Ms. Justice Mini Pushkarna have been nominated to be the Judges of the 'IP Division'.
- 11. Matters to be heard by the IP Division shall be assigned by Hon'ble Judge In-charge (Original Side) between the two IP Divisions.
- 12. In the event of change in the Judges nominated by the Chief Justice constituting the 'Commercial Appellate Division' and 'Commercial Division', part-heard matters shall stand transferred to the Hon'ble Judge who will have the power of 'Commercial Appellate Division' and 'Commercial Division', limited to that case only.
- 13. Hon'ble Judge-in-Charge, Original Side will distribute fresh Arbitration Matters including Commercials Matters under the Arbitration Act, 1940 and the Arbitration and Conciliation Act, 1996 between 'A', 'C', & 'F' Courts.
- 14. Hon'ble Judge-in-Charge, Original Side will mark fresh matters other than Arbitration Matters including Commercial Matters to 'B', 'F' & 'G' Courts.
- 15. All the Hon'ble Judges on the Original Side are empowered to deal with suits/petitions arising under the Arbitration and Conciliation Act,1996 falling under Section 20-B of the Specific Relief Act,1963.
- 16. When a Section 34 petition is pending in respect of a particular arbitral award, the Execution Petition qua the said award shall be listed before the Court where Section 34 petition is pending. Similarly, in cases where an execution petition has been filed prior to Section 34 petition in respect of the same arbitral award, upon Section 34 petition being listed before a Court, Section 36 petition would also get transferred to that Court.

- 17. All matters to be heard by Commercial Appellate Division pending before erstwhile DB-IV shall stand transferred to DB-III.
- 18. All matters to be heard by Commercial Appellate Division pending before erstwhile DB-II shall stand transferred to DB-IV.
- 19. All Arbitration Matters of the year 2023 and 2024 pending in 'D' Court shall stand transferred to 'F' Court.
- 20. All Arbitration Execution Petitions of the year 2024 pending in 'D' Court shall stand transferred to 'F' Court.
- 21. Hon'ble Judge-in-Charge (Single Benches Criminal Jurisdiction) will mark the matters which cannot be listed before roster benches or are directed to be listed before other Criminal Benches. However, mentioning of urgent matters (fresh/pending) of criminal jurisdiction shall be before DB-I only.
- 22. All fresh Bail Applications, Criminal Leave Petitions, Criminal Appeals, Criminal Writ Petitions, Criminal Revision Petitions, Criminal Misc. Main Cases shall be equally distributed amongst Hon'ble Mr. Justice Chandra Dhari Singh, Hon'ble Mr. Justice Anup Jairam Bhambhani, Hon'ble Mr. Justice Manoj Kumar Ohri, Hon'ble Mr. Justice Dinesh Kumar Sharma, Hon'ble Mr. Justice Anoop Kumar Mendiratta, Hon'ble Mr. Justice Amit Mahajan and Hon'ble Mr. Justice Anish Dayal.
- 23. All Bail Applications pending on the Board of Hon'ble Mr. Justice Subramonium Prasad shall stand transferred to the Court of Hon'ble Mr. Justice Chandra Dhari Singh.
- 24. All Writ Petitions (Criminal) pending on the Board of Hon'ble Mr. Justice Subramonium Prasad shall stand transferred to the Court of Hon'ble Mr. Justice Chandra Dhari Singh.
- 25. All Criminal Misc. Cases pending on the Board of Hon'ble Mr. Justice Subramonium Prasad shall stand transferred to the Court of Hon'ble Mr. Justice Amit Mahajan.
- 26. All Criminal Appeals pending on the Board of Hon'ble Mr. Justice Subramonium Prasad shall stand transferred to the Court of Hon'ble Mr. Justice Anup Jairam Bhambhani.
- 27. All Criminal Leave Petitions pending on the Board of Hon'ble Mr. Justice Subramonium Prasad shall stand transferred to the Court of Hon'ble Mr. Justice Anoop Kumar Mendiratta.
- 28. All Criminal Revisions pending on the Board of Hon'ble Mr. Justice Subramonium Prasad shall stand transferred to the Court of Hon'ble Mr. Justice Anish Dayal.
- 29. Cases of the convicts/appellants in jail, whose sentence is about to be completed or have completed the substantial period of the maximum sentence of the offence charged against them, shall be taken up on priority basis and every endeavor should be made to dispose of the same expeditiously.
