#### General Notes:

- 1. All fresh PILs shall be listed before the Bench presided over by the Acting Chief Justice.
- 2. Mentioning of urgent matters will be before DB-I.
- 3. Matters other than part-heard, presently pending before various Benches, shall stand transferred to the respective Benches as per the above roster.
- 4. All Public Interest Litigation Matters irrespective of their being part heard (other than those transferred by the Roster Bench) be listed before the Roster Bench i.e. DB-1.
- 5. Regular/final hearing matters would be listed chronologically so that old matters can be given priority in disposal.
- 6. Specially directed matters may be assigned by the Acting Chief Justice to any of the above Benches or any of the Hon'ble Judges sitting singly or to specially constituted Benches.
- 7. 'Commercial Appellate Division' has been constituted with three Division Benches, namely, DB-I, DB-II and DB-IV. Hon'ble Judges who are members of said Division Benches, as per the present roster, have been nominated to be the Judges of the 'Commercial Appellate Division'.
- 8. Matters to be heard by the Commercial Appellate Division shall be assigned by the Acting Chief Justice amongst three Commercial Appellate Divisions.
- 9. 'Commercial Division' consists of eight benches of a Single Judge each. Hon'ble Mr. Justice Navin Chawla, Hon'ble Mr. Justice C. Hari Shankar, Hon'ble Mr. Justice Prateek Jalan, Hon'ble Mr. Justice Jasmeet Singh, Hon'ble Ms. Justice Mini Pushkarna, Hon'ble Mr. Justice Vikas Mahajan, Hon'ble Ms. Justice Manmeet Pritam Singh Arora and Hon'ble Mr. Justice Saurabh Banerjee have been nominated to be the Judges of the 'Commercial Division'.
- 10. Hon'ble Ms. Justice Mini Pushkarna and Hon'ble Mr. Justice Saurabh Banerejee have been nominated to be the Judges of the 'IP Division'.
- 11. Matters to be heard by the IP Division shall be assigned by Hon'ble Judge In-charge (Original Side) amongst the two IP Divisions.
- 12. In the event of change in the Judges nominated by the Acting Chief Justice constituting the 'Commercial Appellate Division' and 'Commercial Division', part-heard matters shall stand transferred to the Hon'ble Judge who will have the power of 'Commercial Appellate Division' and 'Commercial Division', limited to that case only.
- 13. Hon'ble Judge-in-Charge, Original Side will distribute fresh Arbitration Matters including Commercials Matters under the Arbitration Act, 1940 and the Arbitration and Conciliation Act, 1996 between 'A', 'C', & 'D' Courts.
- 14. Hon'ble Judge-in-Charge, Original Side will mark fresh matters other than Arbitration Matters including Commercial Matters to 'B', 'F' & 'G' Courts.
- 15. All the Hon'ble Judges on the Original Side are empowered to deal with suits/petitions arising under the Arbitration and Conciliation Act,1996 falling under Section 20-B of the Specific Relief Act,1963.

- 16. All Original Side Matters (including Finals) of the year 2024 pending before 'A', 'C' and 'D' Courts shall stand transferred to 'B' Court.
- 17. All matters under Arbitration Act, 1940 and Arbitration & Conciliation Act, 1996 of the year 2024 pending before 'B', 'F' and 'G' Courts shall stand transferred to 'C' Court.
- 18. When a Section 34 petition is pending in respect of a particular arbitral award, the Execution Petition qua the said award shall be listed before the Court where Section 34 petition is pending. Similarly, in cases where an execution petition has been filed prior to Section 34 petition in respect of the same arbitral award, upon Section 34 petition being listed before a Court, Section 36 petition would also get transferred to that Court.
- 19. All matters to be heard by Commercial Appellate Division pending before DB-V shall stand transferred to DB-IV.
- 20. All fresh Bail Applications, Criminal Leave Petitions, Criminal Appeals, Criminal Writ Petitions, Criminal Revision Petitions, Criminal Misc. Main Cases shall be equally distributed amongst Hon'ble Mr. Justice Subramonium Prasad, Hon'ble Mr. Justice Anup Jairam Bhambhani, Hon'ble Mr. Justice Manoj Kumar Ohri, Hon'ble Ms. Justice Neena Bansal Krishna, Hon'ble Mr. Justice Dinesh Kumar Sharma, Hon'ble Mr. Justice Anoop Kumar Mendiratta, Hon'ble Mr. Justice Amit Mahajan and Hon'ble Mr. Justice Anish Dayal.
- 21. All Bail Applications pending on the Board of Hon'ble Mr. Justice Navin Chawla shall stand transferred to the Court of Hon'ble Mr. Justice Subramonium Prasad.
- 22. All Bail Applications pending on the Board of Hon'ble Ms. Justice Jyoti Singh shall stand transferred to the Court of Hon'ble Mr. Justice Dinesh Kumar Sharma.
- 23. All Bail Applications pending on the Board of Hon'ble Ms. Justice Swarana Kanta Sharma shall stand transferred to the Court of Hon'ble Ms. Justice Neena Bansal Krishna.
- 24. All Bail Applications pending on the Board of Hon'ble Mr. Justice Vikas Mahajan shall stand transferred to the Court of Hon'ble Mr. Justice Anish Dayal.
- 25. All Bail Applications pending on the Board of Hon'ble Mr. Justice Amit Sharma shall stand transferred to the Court of Hon'ble Mr. Justice Anup Jairam Bhambhani.
- 26. Cases of the convicts/appellants in jail, whose sentence is about to be completed or have completed the substantial period of the maximum sentence of the offence charged against them, shall be taken up on priority basis and every endeavor should be made to dispose of the same expeditiously.
